





### MEMORANDUM OF UNDERSTANDING

#### 1. Definition of MoU.

The Memorandum of Understanding is a framework agreement between competent institutions in two or more countries, involved in transfer of gained learning outcome(s).

Signing the MoU the institutions:

- Accept each other's status as competent institutions.
- Accept each other's quality assurance, assessment, validation and recognition criteria and procedures as satisfactory for the purposes of transfer of gained learning outcome(s).
- Agree the conditions for the operation of the partnership, such as objectives, duration and arrangements for review of the MoU.
- Agree on the comparability of qualifications concerned for the purposes of transfer of gained learning outcome(s), using the reference levels established by EQF.
- Identify other actors and competent institutions that may be involved in the process concerned and their functions.

The MoU has a specific duration and can be renewed. During its validity period, the MoU defines the overall terms of collaboration of the partners.
